ELECTRIC SERVICE CONTRACT

The undersigned (hereinafter called "Applicant") hereby applies for electric service connection and agrees to purchase electric energy from the SOUTHERN LEYTE ELECTRIC COOPERATIVE, INC. (hereinafter called "Cooperative") upon the following terms and conditions:

1. The Applicant will pay the Cooperative the service and connection fees based on current rate and agrees to have his premises be wired in accordance with wiring specifications approved by the cooperative.
2. The Applicant is the official representative of the group requiring electric service and therefore responsible for the group's legal and financial obligations to the Cooperative.
3. The Applicant agrees to collect from the group members their individual electricity consumption at a rate based on computations conforming to the Cooperative's current rate and load consumption computation procedure (Watts x hours x no. of days).
4. The Applicant shall not in any way overcharge its members and any exorbitant unauthorized charges may result to eventual discontinuation of service.
5. The Applicant will comply with and be bound by the provisions of the charter and by-laws of the Cooperative and such rules and regulations as may from time to time be adopted by the Cooperative.
6. The Applicant shall indemnify, save harmless and defend the Cooperative against all liability, claims, judgements, costs and expenses for injury, loss or damage to persons or property on account of defective construction, wiring or appliances on Applicant's side of point of delivery.

7. The Applicant will grant the Cooperative at its request the necessary rights and easements to construct, operate, replace, repair and perpetually maintain on the property owned or leased by the undersigned and or upon all roads, streets or highways abutting said property, its lines for transmission or distribution of electric energy and will execute and deliver to the Cooperative any conveyance, grant or instrument which the Cooperative shall deem necessary or convenient for the said purposes or any of them. All lines of the Cooperative and switches, meters and other equipment constructed and installed by the Cooperative on said property except so much thereof, if any, as shall be paid for by the undersigned, shall at all time be the sole property of the Cooperative and the Cooperative shall have the rights of access to said property to operate, maintain or relocate its facilities.
8. The Cooperative does not guarantee continuous service but shall use reasonable diligence to provide uninterrupted service hereunder, and having used reasonable diligence, shall not be liable to the Applicant, for damage caused by service interruptions or suspensions of same. The Cooperative reserves the right to suspend services without liability on its part, such times for such periods and in such manner as may in its judgment be required for the purpose of making necessary repairs on the lines or other part of its system.
9. The Cooperative is expressly authorized and empowered to remove its property and to discontinue furnishing electric energy should Applicant fail to comply with any of the rules and regulations of the Cooperative, or become delinquent in an account due to the Cooperative for electric energy.
10. The Cooperative shall not be liable for damages caused by wiring or other accessories installed by the Applicant in his premises not in proper condition.
11. The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative and the contract for electric service shall continue in force from the date service is made available by the Cooperative to the Applicant, and as long as the Applicant has need for any electric service on the subject premises.
